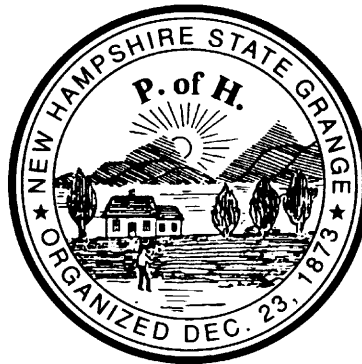

**JOURNAL OF PROCEEDINGS OF THE
NEW HAMPSHIRE STATE GRANGE

After a festive Thursday evening including the annual meeting of the New Hampshire Grange Foundation, candy bingo hosted by State Lecturer Matt Clark and an ice cream social, the first full day of the 152nd annual session of the New Hampshire State Grange was opened in the Sixth Degree at 8:40 am, on Friday, October 17, with Worthy Master Tricia Taylor and the officers of the New Hampshire State Grange.

Roll call of officers found all present. Roll call of Granges found a quorum present.

The Grange was then lowered to the Fourth Degree. Unfortunately, there were no honored guests as our scheduled National Grange Representative had a conflict.

Introduction of Master's Address Committee: Pat Bailey, Diane Collins, and Kimber Bascom

Introduction of Resolutions Committee: Leroy Watson, Christopher Heath, and Scott Burns

The Standing Rules for the 152nd Annual Session were read. A motion was made by Christopher Heath of Centennial Grange and seconded by Sarah Leclerc of Hillsborough County Pomona to adopt the rules. It was a vote in the affirmative.

Master Tricia Taylor read a proclamation from Governor Kelly Ayotte honoring our Session. Members then viewed a video message from National Grange President Christine Hamp, which

included shout-outs to Wilber and Jane Heath, Bob and Jane Trombi, and Leroy Watson. She announced Grange Engage, National's new membership software and spoke of Project Sustenance, growing food security, self sustainability, and resilience in America's hometowns, as well as the Rural Life Initiative and the upcoming National Conference. She encouraged us to "kick it up another notch", change what isn't working and shine a light on what is.

Norman Brandt was escorted to the Master's Station to share the report of the Agriculture Committee. *The report was accepted and ordered printed in the Journal.*

Master Tricia Taylor mentioned that this will be a slower paced Session, and declared a brief recess.

Beth Merrill presented the report of the NH Trustees of the New England Grange Building. Members were encouraged to share their guesses of how much money was raised for St. Jude's Children's Hospital to Beth during Session. The winning guess, without going over, will win a prize. She mentioned that donations of crafting supplies, such as yarn and fabric are welcome. *The report was accepted and ordered printed in the Journal.*

Bingo cards were passed out to those who were not in attendance last night, so the games could continue, with Lecturer Matt Clark calling numbers.

Gerald J. Leclerc, Session Coordinator, presented his report. The hospitality room is Room 112, and will be open at lunch. While there will not be an evaluation form this year, attendees are encouraged to share comments or concerns with the Session Coordinator. Members were asked to block October 15-18, 2026, on their calendars for next year's State Session at the Fireside Inn & Suites. Brother Leclerc then presented a brief report on his work as an Executive Committee member. *The report was accepted and ordered printed in the Journal.*

Master Tricia Taylor declared a five-minute recess for Memorial Service rehearsal. When session resumed, Mary West announced that colored pencils are available at the back of the room for those who wish to use the coloring page included in their Session program.

Mary West presented her report as Webmaster. *The report was accepted and ordered printed in the Journal.*

Steward Norman Brandt announced honored guest Shawn Jasper, NH Commissioner of Agriculture. Commissioner Jasper was escorted to the Master's office for remarks. He was honored to join us, and mentioned that a picture of Past State Master, Past National Master and Past NH Governor Nahum Batchelder's barn is going to be the new homepage of the New Hampshire Department of Agriculture's website. He shared about Brother Batchelder's years of service, and his desire to do a better job of honoring him. Since 1870, there have only been nine commissioners of agriculture! Past and current NH agriculture news include potato and tobacco farming and poultry farming. He highlighted the work of the Hubbard family, and Pete and Gerry's. NH is moving into hydroponics and pick-your-own, which will keep young people involved in agriculture. He advocated that agriculture is viable in New Hampshire but not in the traditional methods. He's excited about agriculture in New Hampshire despite labor shortages, as

we are innovative. The Commission is currently well-staffed and has hired Dr. Prescott as our new state veterinarian. They are working to battle consumer fraud and update technology, and are concerned about an increase in pet vending and its effect on health.

Master Tricia Taylor declared an 11-minute recess to set up for the Memorial Service. Sister Kim Bascom announced that the silent auction is now open. Bid high and bid often! The hospitality room will be open for lunch at noon. Banquet ticket payments should be given to State Ceres Gloria Davis.

At 11 am, the gates were closed for the annual Memorial Service, under the direction of State Chaplain Kathy Yardley. *The program was ordered printed in the Journal.*

Master Tricia Taylor declared a recess until 1:30 pm.

The afternoon session was called to order at 1:34 pm. Beth Merrill introduced State Master Tricia Taylor to give the Master's address. *The report was accepted, ordered printed in the Journal and turned over to the Master's Address Committee.*

Diane Collins, Chair of the Trustees of Trust Funds, gave her annual report from the Overseer's station. *The report was accepted and ordered printed in the Journal.*

B. Richard Bailey presented his report as Historian and Executive Committee member. *The report was accepted and ordered printed in the Journal.* He then shared his fascinating presentation "Grange: The Role of the Grange in the Development of Today's Society".

The State Lecturer called six more Bingo numbers prior to a ten-minute recess.

The Grange was called back to order at 2:52 pm. The Lady Assistant Steward escorted Andrew Savage to the Master's station to give his report as Youth Director. *The report was accepted and ordered printed in the Journal.*

Master Tricia Taylor was pleased to announce that she's already had someone volunteer to assist with fair displays next season.

Joann Brandt, was escorted to the Master's Station to give the Junior Director's report. She presented a Junior Grange graduation certificate to Rebecca Boisvert, and shared certificates to be passed along to Lily Ricker, Jacob Scanzani, and Georgiani Farrell. *The report was accepted and ordered printed in the Journal.*

Beth Merrill reminded members that she's accepting guesses as to how much money was raised by the Big E Trustee's quilt raffle.

Matthew Clark called six more Bingo numbers, resulting in Bingo for State Overseer Arthur Merrill, before presenting his report as State Lecturer. Make note that State Grange Bowling will take place on *Saturday*, March 28, at 12 noon, at Lakeside Lanes, in Manchester. Prize envelopes

were awarded for winning contest entries. *The report was accepted and ordered printed in the Journal.*

Anne Boisvert, presented her report as the State Grange building manager. *The report was accepted and ordered printed in the Journal.*

Sherrill Bokousky, Grange Services Director, was escorted to the Master's station to give her report. *The report was accepted and ordered printed in the Journal.*

Mary West requested that any sixth-degree candidates submit their paperwork as soon as possible. Kathy Yardley announced that baking contest entries must be received by tomorrow morning. The hospitality room is open until 4:00 pm. If you are interested in filling a State office for Saturday's opening, please notify Arthur Merrill. A random drawing will be conducted this evening. The silent auction and display room are still open. Andrew Savage needs to know the identity of wreath contest participants.

With no further business to conduct, Worthy Master Tricia Taylor raised the Grange to the sixth degree and declared the Grange at ease at 3:30 pm, until 7:30 pm.

After fifth degree obligation, the Friday evening session opened at 7:30pm with a procession by the officers of the New Hampshire State Grange. Roll call of officers found all present. State Secretary Mary West announced that Rebecca Boisvert of Chichester Grange #132, Janel Hopkins Pierson of Rochester Grange #86, and Bridgid Stiller of Blow Me Down Grange #234, were seeking admission to the Court of Flora.

The second day of the 152nd Annual State Grange Session was opened in the Fourth Degree by Master pro temps Norman Brandt at 8:30 am.

Roll call of both volunteer and elected officers found all present. Roll call of Granges found a quorum present. The minutes of yesterday's session were read, approved, and ordered printed in the Journal. Master pro temps Norman Brandt then declared a brief recess so the elected officers could take their places.

The Standing Rules of the 152nd Session were read for reference only.

Daniel Bascom presented the State Treasurer's report. *The report was accepted and ordered printed in the Journal.*

After a brief recess, we reconvened at 9:30 am for election of officers. Appointed tellers were Glen Eldredge, Brian Twiss, and Deb Patten. With 37 votes cast, 20 votes were needed for election.

Beth Merrill announced that \$8,806 were raised for St. Jude's Children's Hospital with the NH Trustees of the New England Grange building quilt raffle. Jane Heath was recognized for helping with the quilt and for her lofty guess. Anne Boisvert had the winning guess. Both received a jar of fruit preserves from the New England Grange building. Beth also mentioned that she does not wish to be re-elected to the Executive Committee.

After Glen Eldredge's name was suggested for office, Trevor Clark was swapped in as an appointed teller.

Sarah Leclerc escorted herself to the State Master's station to give her report as State Lady Assistant Steward. *The report was accepted and ordered printed in the Journal.*

With 34 votes cast, Glen Eldredge was unanimously elected. Brother Eldredge accepted and Master Tricia Taylor declared him elected to the State Grange Executive Committee for the constitutional term of three years.

Mary West presented the State Secretary's report. *The report was accepted and ordered printed in the Journal.*

Arthur Merrill approached the Master's station and presented the report of the State Grange Executive Committee as well as a report on State Officer visits. Nearly 3000 miles were traveled. State Officers were asked to share their requests for next year's visit assignments. *The report was accepted and ordered printed in the Journal.*

Brother Dan Bascom spoke in his role as Past State Master. He encouraged support of Granges, even those that seem small, giving the example of Wicwas Lake, which was struggling when he was State Master 25 years ago, but is now our biggest Grange. He advised us to hang in there, do the best we can, and try to get some new members.

General Deputy Wilber Heath presented his annual report as General Deputy. *The report was accepted and ordered printed in the Journal.*

Emilie Leclerc presented her report as State Pomona. *The report was accepted and ordered printed in the Journal.*

Adam Terrell presented his report as State Gatekeeper. *The report was accepted and ordered printed in the Journal.*

Members viewed a video clip about the NH Preservation Alliance's Seven to Save, featuring Golden Rod Grange Hall, in Swanzeey. More Bingo numbers were read unproductively.

Jim Tetreault was escorted to the Master's Station where he was joined by Gloria Davis to present the Membership Committee report. He encouraged members to take membership brochures home. They're available on the Membership table in the display room. *The report was accepted and ordered printed in the Journal.*

Gloria Davis shared her report as State Ceres. *The report was accepted and ordered printed in the Journal.*

Pat Bailey and Pat Lawlor sneaked to the Master's Station from credentials, to present the annual report of the Granite State Granger. *The report was accepted and ordered printed in the Journal.*

After a ten-minute recess, Kathy Yardley and Joyce Martin, Family and Community Committee Directors, were escorted to the Master's station to give their annual report. They presented awards for needlework, woodworking, community service notebooks and reports, and the baking

contest. The remaining mini cheesecakes are available in the hospitality room. Next year's baking contest will be quiche! *The report was accepted and ordered printed in the Journal.*

Kathy Yardley remained to share her report as State Chaplain. *The report was accepted and ordered printed in the Journal.*

Lynn Clark approached the Secretary's Station to present the report of the State Flora. *The report was accepted and ordered printed in the Journal.*

Lester Gibbs shared the report of the State Musician. He advised that he's glad to help out with music for Grange degrees and award ceremonies and encouraged Granges to reach out. *The report was accepted and ordered printed in the Journal.*

Another round of Bingo numbers resulted in two winners: Chris Heath and Joyce Martin.

Anne Boisvert approached the Master's Station to share her report as a State Executive Committee member. *The report was accepted and ordered printed in the Journal.*

Beth Merrill approached the Master's Station to share her report as a State Executive Committee member. *The report was accepted and ordered printed in the Journal.*

Master Tricia Taylor reminded members that the hospitality room 112 will be open for lunch. Mary recommended that program packets can be signed out from her during afternoon session. The silent auction is still open! After playing Bingo until there were winners: Andrew Savage and Sandra Marcoux, we recessed for lunch until 1:30. There may be changes to the budget, so don't be late!

After a recess for lunch, the session reconvened at 1:32 pm. Arthur Merrill, Chairman of the State Executive Committee, approached the Master's station to present the 2025-2026 Income and Expense Budgets. State Treasurer Dan Bascom shared that this will be the second year for a vote on a dues increase at National Grange. If it passes, we will need to pay \$20 per member to National Grange each year, effective January 1. He'd also like to add reimbursement of mileage for officer visits. The proposed "National Session 2028" amount was in error and should be \$0.00. A motion was made by Lynn Clark and seconded by Jerry Leclerc of Hudson Grange to approve the Budget as corrected during discussion. It was a vote in the affirmative. *The income and expense reports were accepted and ordered printed in the journal.*

Leroy Watson, Chair of the Resolutions Committee approached the Master's station to present his report.

Resolution #1 - Submitted by Blow Me Down Grange #234

Subject: *Including Past State Masters and Spouses as Voting Delegates to State Session*

The committee recommended that the resolution not be passed. Motion made by Don Ross of Wingold Grange and seconded by Andrew Savage of Wingold Grange. It was a vote in the affirmative. The resolution failed.

The report of the Resolutions Committee was accepted and ordered printed in the Journal.

Brother Jim Tetreault shared remarks in his role as Past State Master. He was pleased to be back with us this year and to support the Clark family. He congratulated Tricia Taylor on a session well-run and congratulated Beth Merrill on her retirement from the Executive Committee. He thanked Leroy Watson for transporting him.

Brother Bob Trombi shared remarks as the most recent Past State Master. He's happy to be here, and promised that despite three strokes he was not planning to strike out.

Pat Bailey, Diane Collins, and Kimber Bascom approached the Master's station to give the report of the State Master's Annual Address Committee. *The report was accepted and ordered printed in the Journal.*

Pat Bailey was then joined by Pat Lawlor to present the report of the credentials committee. *The report was accepted and ordered printed in the Journal.*

Sister Beth Merrill shared remarks in her role as Past State Master. She mentioned her pet peeve that outside organizations confuse a "Grange Hall" with the "Grange". She asked us to correct that misnomer when possible. She also encouraged members to contribute exhibits to local fairs. She commended this morning's opening, which was on the youthful side. She's hopeful we can re-create a well-banded youth in the State and even have a slate of youth officers to open Saturday's session next year. Finally, she thinks there may be National Grange plans for next year's 250th celebration for America. Look for details on the website and in Good Day magazine about photo submission for the celebration and perhaps reach out to organizations in your community about planning celebrations at a local level.

Glen Eldredge was escorted to the altar where Arthur Merrill installed him as a State Executive Committee member for the constitutional term of three years. Beth Merrill served as Marshall. Brother Eldredge thanked us for the privilege and shared a few words of wisdom.

Announcements: The hospitality room has food to be taken home. A round of applause was shared by the room in appreciation of the hospitality room, hosted by Blow Me Down and Park Granges. Motion made by Alice Tuck of Rochester Grange and seconded by Gloria Davis of Antrim Grange that the State Grange donate \$200 to Park Grange to reimburse. Amendment suggested by Chris Heath of Centennial Grange and seconded by Emilie Leclerc of Hudson Grange to raise the amount to \$400. Amendment passed. Amended motion passed. Blow Me Down and Park Grange have already offered to manage the hospitality room at next year's session. Matthew Clark and Kathy Yardley reminded members to collect their items from the exhibit room. Kimber Bascom announced that the silent auction bidding will end at 3 pm. Mary West asked members to please take commemorative session ribbons home, collect program packets and return their name badge holders for reuse.

Andrew Savage quickly shared his Assistant Steward report. *The report was accepted and ordered printed in the Journal.*

A motion was made by Matthew Clark of Arlington Grange and seconded by Christopher Heath of Centennial Grange that the Executive Committee approve the minutes for today's session. It was a vote in the affirmative.

With no further business to conduct, the second day of the 152nd Annual State Grange Session was closed in the 4th Degree at 2:42 pm.

The Annual State Grange Banquet was held under the direction of State Ceres, Gloria Davis. After a roast turkey dinner and giant slices of chocolate cake, Kathy Yardley gave a brief handbell lesson. The future Grange handbell choir of Matthew Clark, Seth Clark, Rick Bailey, Robin Doucette, Mary West and Sandra Marcoux performed a few numbers.

Matthew Clark then presented the Granger of the Year award to Beth and Arthur Merrill.

A round of applause was given to Jerry Leclerc for arranging a great Session. Members then joined in a group sing-a-long of familiar tunes. The holiday-themed centerpieces were taken home to be enjoyed by those who wished.

AGRICULTURE REPORT

Worthy Master, Brothers, Sisters and Delegates alike.

A year has passed and it is time once again for me to stand before you and give a report. For those that were visiting Mars or the moon this past year we started off wet, with rain every weekend. Seeds were rotting in the fields and people started praying for the rains to stop. And you should always be wary of what you pray for, on the chance they are granted, and they were. We went from too wet to too dry. Drought has moved from the north to the south of NH as the rains stopped. As the rains caused great strawberry and blueberry harvest the lack of rain stunted much of the other harvest. Speaking to the maple producers at the Deerfield Fair, maple production was great if you like dark and very dark syrup because they got a lot of it.

I’m getting ahead of myself. Before Deerfield, there were many other things. Let's start with the Farm, Forest and Garden Expo, at the Deerfield Fairgrounds. Once again NH State Grange had an exhibit at the fair. This year we had a small petting area full of stuffed toys (being right after Easter I saw them 90% off so about a dollar or less an animal so I got quite a few). Using pool noodles we made a little pen and lined it with AstroTurf. We had many coloring pages for people to color while chatting, or while waiting for their kids to leave the petting area. MASTER’S ADDRESS

Worthy State Officers, Delegates, Brothers and Sisters,

It is my honor to stand here and give my third Master’s Address. This year has been anything but quiet with a series of ups and downs. There’s been quite a bit of traveling as well as being present at several Granges that were taking in new members. This was good to see. Hopefully more of our Granges will be able to do the same this year.

On the flip side I did close Mascoma Valley Pomona as they have not been meeting for quite some time. Their members have been transferred to Pemigewasset Valley Pomona. Mt Livermore Grange in Holderness has been consolidated with Lower Intervale Grange. There are two more Granges that are on the list although we are going look at a consolidation for the one that has been inactive for a number of years. There is another Pomona that needs to resume being active in order to stay alive. If you belong to a Community or Pomona Grange that isn’t meeting or is struggling, please do your best to support reactivating that Grange and getting involved with your community.

Last year I challenged each and every one of you to make the effort to visit other Granges. The State Officers were all assigned two Granges that were not part of their Deputy Districts to visit. Although I did not receive reports from all of them I believe that most of our State Officers did make their visits or at least attempted to do so. We’ll find out as we hear their Officer reports this weekend. The State Officers will be given different Granges this coming year to visit and report back on.

I know that the various meetings I have attended this year have shown how busy many of our Granges are in their communities. I will not close a Grange that is active in their community

even if they have trouble getting a quorum. Were we to close those Granges we would be cutting our numbers drastically. That is not something I want to do.

Last year I also reminded you that it was the incorporation year for non-profits. During our last Executive Committee meeting our Worthy Treasurer informed us that 16 Granges still had not filed their incorporation papers. That is about half of our Granges. Yes, you do have until December 31, but please don't wait until the last minute. This is important and with the hustle and bustle of the holiday season it could easily be forgotten.

We have a few Granges who are working the various degrees. I encourage all of you to keep an eye on the grapevine and make a note of where and when these are being done. I did miss the notice for Centennial and Eastern NH and their degree night but I did make it to Antrim and Arlington. I did learn last weekend that Chichester has also begun working a degree. It is good to see Grangers trying to revive the ritual. Most of us have new members that have never seen a degree. Some probably haven't been obligated. Seeing these degrees give them a better understanding of the Order they have joined. I know that each of these Granges would welcome new members from other Granges to join them when the degree is being worked. They would probably also appreciate anyone who would be willing to fill an office for a degree.

As usual our Agriculture and Membership Committees did an excellent job representing us at Farm and Forest. This group has always competed in the "theme contest" and have won quite a number of times. The winner gets a free booth the following year which certainly helps with costs. This year there were only two groups competing in the "theme contest" so the Board decided not to judge the two and to not award the prize. That was a disappointment for all of us who knew. Hopefully the judging will take place at this coming year's Farm and Forest Expo.

The NH Preservation Alliance's Old House and Barn Expo will be taking place this coming year as they hold this event every other year. I have no doubt that we will be well represented at this event. I received several compliments about our display in 2024, and hope to do that again. The Agriculture Director, Norman Brandt, is quite creative and has lots of good ideas for entertaining visitors to the NH State Grange booths. Add in the Junior Director Joanne Brandt and the Membership co-chair Gloria Davis, and good things happen.

Along with the NH booths at these two events there is also the opportunity to advertise both your own Grange as well as Grange in general at the many fairs held around the state. Sister Beth Merrill brought up the idea that we encourage participation by individual Granges in the various fairs as well as looking for people who would be willing to take on the task of showcasing us in each of the fairs, or at least as many as possible. The Committees that might ordinarily be charged with this are quite small and I don't wish to burden them further. I would appreciate anyone interested in creating a booth and then getting it to and from the various fairs in the coming year to get in touch with me. I remember putting displays together at both Plymouth and Hopkinton Fairs for many years. It was always fun to go through and check out all the displays. Plus...the prizes are pretty good these days. Some fairs give \$100 prizes for first place so it can also be a fundraiser if you get to more than one fair.

I have enjoyed traveling to many Granges this year, as well as to National and regional events. The Northeast Leader's Conference was held in Massachusetts, in January, and the National Leader's Conference was held in California, in February. NH Junior/Youth Day was also held in February. In March, I attended the Executive Committee meeting and our first Director's meeting. It was well attended and many ideas were exchanged. March also included the Moonstomp and Bowling. In April, it was time for the first trip to the Big E for the Northeast Connection and the New England Grange Building Trustees meetings. May was Farm and Forest Expo as well as a Youth Day. National Session Committees began meeting by Zoom in May, but unfortunately, on Mother's Day, I again demonstrated my inability to walk without getting hurt. Most of you probably heard that I tripped and went face first into a hardwood door. As a result Sister Beth Merrill represented me at Joe English Grange's 150th anniversary, and Brother Arthur Merrill represented me at Blow-Me-Down's instruction. I truly appreciate their help. I missed Family and Community Service Day yet again, and pretty much canceled everything for 3 to 4 weeks. I did not set up a Family Weekend this year as half of us were going to be in Utah and I prefer to be in attendance for events I'm in charge of. I hope to resurrect it this coming year. The rest of the month was spent traveling to and from Torrey, Utah, for the Grange Revival. What an amazing place! August brought back another Executive Committee meeting, National Zoom meetings, and a Director's meeting. Speaking of which: all of you who were at that meeting and had suggestions for places to hold the Northeast Youth Rally please let me know what you found out concerning availability, costs, etc. We want to have this nailed down by Leader's Conference in January. September was kept busy by my own Grange's events and visiting other Granges.

I continue to encourage all of the Grangers in the State to get out and visit other Granges. Making the effort to attend the various State events is also important. I know people still say we aren't youth so we don't have to go. This is also true for various other events. Yes, we need to do more advertising so people know what is coming up. Why would new members of any age want to attend events that aren't even well attended by current members? If we want to stay alive we need to do better.

I also continue to encourage all the Granges to send a copy of their by-laws to our State Secretary, Mary West. I know that some of you have already done so, and some have given copies to their Deputies. We still need to get a complete set.

Holding the Director's meetings this year has been informative and led to some excellent brainstorming. I intend to continue those meetings this year. I reiterate the need for feedback on the places suggested as places to host the Northeast Youth Rally. That information would be very helpful to have at Deputy School on December 13, at 10 am. Include any place you feel would be a good place to visit.

In my letter in the last GSG I included information about the new National membership program. It is actually called "Grange Engage". I have not heard any more about the official launch of the program unless there was something included in the National Master's video this morning. I recommend that when it is launched you spend some time surfing all of the levels it includes.

NH TRUSTEES OF THE NEW ENGLAND GRANGE BUILDING

Worthy Master, State Officers, Delegates, and Patrons:

I am pleased to bring you this report of the NH Trustees of the New England Grange Building. For the audience today that may not be familiar with the importance of this facility, it is a lovely representation of a traditional Grange meeting place built by New England Grangers, for New England Grangers, in 1938, on the grounds of the Eastern States Exposition in West Springfield, Massachusetts. It is operated under the guidance of twenty-one trustees comprised of three members from each New England state and New York and the building staff appointed by the trustee board. Noel Miller, building manager, Dawn Percoski, needlework and crafts manager, both of Connecticut, and George and Patti Thomas, store managers, of Massachusetts, are the Grange heroes who dedicate their time and talent for more than the grueling seventeen days of the Big E to make sure our beautiful house is open, well-stocked, clean, and welcoming to the thousands and thousands of visitors who enter the building during the fair.

There were three trustee meetings held this year. The Northeast Region gathered for the Leaders' Conference in Massachusetts in January, which included the annual meeting of the New England Grange Building trustees. All three of the NH trustees were in attendance and Matthew Clark was elected president. Discussion at this meeting included discussing the successes and challenges of providing our second vaccination clinic at the 2024 fair as well as changing our by-laws to create youth trustee positions, which we've been working on for the past three years. I was tasked with creating an application process for selecting up to three Youth Trustees over the course of the next three years.

A second meeting was held in the Massachusetts Building on the grounds at the Big E in April, again with all three NH trustees in attendance. It was noted by the building manager that there likely would not be a vaccine clinic for a third year as the federal grant that funded this is no longer available, a result of current governmental changes. The board voted to purchase a new router and security cameras, to replace the crumbling upstairs window blinds, and to purchase new vests for the staff to wear during the fair.

The traditional work/cleaning meeting was held on site at the building in June, for which Tricia, Matt, Arthur and I travelled once again to West Springfield. We spent some time in the NH room assessing areas that needed updating, especially the photo frame of Past Masters that needed photos of the three most recent ones.

Arthur and I accompanied Family and Community Directors, Kathy Yardley and Joyce Martin, on Labor Day, when they made the trip to the building to deliver the needlework contest entries and the accumulation of handcrafted goods donated by NH Grange crafters. During the visit, Kathy and Joyce assisted the Craft Sales Manager, Dawn Percoski, and her crew of volunteers in

pricing the mountain of donated items. Arthur and I also helped with this once we finished updating our Past Masters photo display and doing a deep clean in the NH room.

During the fair, Arthur volunteered at the Grange Building on NH Day and then we both returned on Grange Day to be monitors in the NH room upstairs. It was delightful to meet and chat with visitors who expressed appreciation for this chance to see the second level of the building normally closed off to the public. We appreciate the nice job that Brother Rick Bailey did in repairing the NH-shaped clock, which received several comments from visitors during the day. I have a goal for next year and would like to try to fill one week of the 2026 fair with volunteer NH Grangers willing to attend as upstairs hosts. Look for details in future communications as details become available. This was suggested by members of Dorchester Grange during my State Officer visit and they expressed interest in participating in such an opportunity. They also were very generous in making donations for the quilt raffle, which I was happy to take with me and submit their entries during one of my fair visits. I will try to be more timely in extending an invitation to all Grangers to do the same next year.

The fair this year was blessed with favorable weather most all of its seventeen days, resulting in a total attendance of 1,538,463 visitors, down just a bit from last year's record-breaking number. We had a banner year for both the store and craft departments. The store jams and jellies had a slight increase and brought in \$14,818.55. The Craft department had a significant increase and brought in \$20,888.00! The amount continues to increase due to the quality of donations which allows our manager to increase the prices of those items while at the same time keeping them less expensive than other vendors throughout the fair. People know this and come into the fair just for our items. Our reputation truly precedes us!

This year's quilt was made, under the direction of Sister Jane Heath of Centennial Grange, by a group of New Hampshire crafty ladies, (longarm services provided compliments of The Wicked Quiltah in Antrim) and it broke the record by a landslide with a donation to St. Jude Children's Research Hospital of \$8,806.00. The winner for the quilt raffle was a lady who lives in West Springfield and she was so thrilled to have won. Just as a note, this was the 20th year that we have been raffling off quilts for donations since the very first one in 2005 that helped victims of Hurricane Katrina. To date, we have raised over \$77,000.00 for a variety of charities, usually benefitting children or veterans.

Scrubbies, crocheted out of simple netting fabric, are worth their weight in gold, it seems, and this year was no exception, as our limited supply was sold out by the third day of the fair. Recruiting new volunteers to learn to make these should be a priority and sponsors to help purchase the netting material, would help this endeavor, especially since the closing of all the Joann Fabrics stores, eliminating a great resource that offered frequent sales. Dish cloths, hanging towels, baby items, and Christmas ornaments continue to be big sellers. Hats, scarves, and mittens are also good sellers, as are pet items such as catnip fish, tennis balls on a rope and other such treats. Large size quilts and afghans are selling well, with customers showing a willingness to pay the big price for them. I was able to finish quite a few afghans and other projects of varying sizes given to me as UFOs (unfinished objects). It is a good feeling to get them done and out of the house.

We DO so much appreciate all your handmade donations and hope that you are able to continue your generous gifts of time and craftsmanship. Grange meetings are a good venue to get your members together to work on fun, simple projects. If your group is not handy, nor interested in making things, but can contribute financially you might consider purchasing gift cards to Michaels or Hobby Lobby, then materials can be purchased by those who are crafty but unable to donate more than their time. Proceeds from these sales go to the maintenance and improvements to the building.

I hope each member can find a way to support this unique part of our Grange heritage in the coming year. There are plenty of small ways everyone can contribute to help in a big way to preserve the legacy of the Grange at the Eastern States Exposition. And perhaps 2026 will be the year that YOU venture your way south to experience for yourself all that the Big “E” and specifically, the New England Grange Building, has to offer. We hope to see you there!

RESOLUTIONS COMMITTEE

Worthy Master, Worthy State Officers, and Brothers and Sisters,

Your Resolution Committee reviewed one resolution submitted for consideration by this Year's Convention. A Resolution to amend the National Grange Digest of Laws entitled "Past State Masters and Spouses as Delegates to State Session", submitted by Blow Me Down Grange #234.

This resolution is technically well constructed and written. It clearly identifies the issue that the authoring Grange believes needs addressing in the Whereas clauses and proposes a specific solution to amend the National Grange Digest of Laws in the Resolved clause. The reader of the resolution can clearly understand the intent of the resolution without having to refer to any outside sources of information.

However, your resolution committee, nevertheless, recommends that this resolution not be adopted for the following reasons:

The committee members do not believe that this resolution reflects a pressing National issue that needs to be addressed by amending the National Digest of Laws. Adopting this resolution would require separate votes, with two-thirds majority each time, at two concurrent Annual Sessions of the National Grange, or a 5% vote at one National Grange Annual Session, to be adopted. This is the most challenging amendment procedure in the National Digest of Laws and requires near unanimous consensus that the proposed amendment is both necessary and urgently needed to be adopted for the Good of the Order.

The committee members expressed doubt that the National Delegates would be convinced of the benefit of adopting this resolution. Many National Delegates would likely see this as a state issue, not a national issue, that imposes a uniform solution on all states, and that would better be individually addressed by State Granges.

Finally the committee members expressed their beliefs, from personal experiences attending various State Grange Conventions in New Hampshire and other States, that former State Masters and their spouses were generally well respected at their State Grange conventions and held in high regard. They were almost always given the privilege to speak to matters before the State Grange and share their experience, by the presiding State Master, either by tradition or State Constitutions. Granting former state masters and their spouses the right to vote at annual State Grange Conventions would not substantially encourage these respected Grange leaders to stay involved and active in the affairs of their Subordinate, Pomona and State Granges, because, overwhelmingly, they already are staying active, to the best of their abilities.

Your Resolution committee would like to encourage more local Granges to submit resolutions for consideration to the Worthy State Secretary, next year by the September 1st deadline. Considering resolutions is one of the main functions of the Annual Convention of the New Hampshire State Grange.

SESSION COORDINATORS REPORT

Worthy Master, State Officers, Delegates, Brothers and Sisters

I hope you all had a pleasant ride and enjoyed what is left of the fall foliage here in this part of the State.

Welcome back to the Fireside Inn and Suites in West Lebanon, NH. It has been several years since we were last here. For some, including myself, this is one of my favorite places to have session. The staff has been very flexible with some changes that were made during the planning process and are here to help us during our stay.

As in the past, several visits were made to the Fireside to meet with our representative to discuss our needs, room set ups, menu options, timing for resetting the ballroom for the banquet, and, in general, how they can be of assistance to us.

At last year's session, it was decided not to have the traditional session evaluation forms filled out. Instead, a survey was sent to each Subordinate and Pomona Grange following the session. The letter included with the questionnaire asked each Grange to take time during one or several meetings to discuss the questions and share ideas of what they would like to keep or change about State Session. To keep this anonymous, Granges were asked to send these to the State Secretary.

The remainder of my report will focus on what the Granges responses were to the questions. First, let me tell you that most of what was shared has been included in this report; a few responses were not appropriate for this exercise, and therefore will not be added.

Comments: too much time spent marching report givers to and from their seats.

Location: 8 would like session to be held in different parts of the state

6 would like to stay at one location

1 had no comment

Several ideas for locations were suggested and will be looked at for future sessions.

Time of year to hold session: Most responses were in favor of keeping it when it is currently held. Another was anytime in October except for Halloween weekend. One likes the spring when more are likely to travel, and it gives the State Master time to prepare for National Session.

Workshops:

- Lecturer tips and ideas
- Demos where we can participate opposed to sitting and watching.
- How to write resolutions.
- Using Canva or AI to our advantage
- Scrapbooking or other craft activities
- Ideas for increasing Membership
- Local Historical Society, NH Humanities Council, NH Cooperative Extension, Fish and Game, Educational type
- Irish step dancing

Conferral of Degrees: All responders were in favor of degrees being conferred at session. Frequency suggested was to have one degree performed each year starting with the First Degree. Most did comment that they need to be done well and memorized. (or at least not being read from the book for the first time). Doing the degrees may encourage new members to continue through all degrees including the Fifth and Sixth.

Sixth Degree: Response varied in the frequency and whether to not do it at all.

- Most popular response was every other year on non-election years. This would hopefully bring in a larger class of candidates providing that subordinate and Pomona Granges take in new members.
- Open with it on Saturday morning
- Confer it on Friday or Saturday afternoon.
- Do away with lengthy extras such as introducing all past officers and Honor Court.
- Need to make Pomona more inviting as to encourage members to take the sixth degree
- Have the State Secretary request in a letter leading up to the Annual Session, asking who will be taking the sixth degree encouraging them to fill out an application and return for a possible count of candidates.
- Only do the degree on four or more candidates.

State Grange Banquet:

- Several responded, no banquet
- No buffets
- Cheaper meal choices
- Do a church or potluck supper.
- Less fancy food.... Burgers and fries, for example
- Bar service for those who would like a glass of wine or other beverage options with their meal.

Responses for what to do at the banquet varied with wanting music (mood setting or dancing after), guest speakers, Grange awards, Community Awards (State Police, Teacher, Firefighter, Community Citizen, Century Farm and Young Farmers)

It is my opinion that if we make the banquet more of a celebration event than just a meal, we could have increased attendance.

Reports:

- Only information about the office or department activities. No vacation or personal stories. Keep them Grange related.
- Preprint reports and have them included in the session packets.
- Be more positive in reporting
- Report how many entries in the various contests were submitted. Low participating contests should be removed or highlighted more throughout the year.
- Read report from paper not cell phones and laptops.
- If time allows present awards during the report, have the recipients remain at the front of the hall for a group photo.
- Announce any new activity or contest for the coming year. Leave us wanting more.
- Would have been fun to hear some of the Seuss readings last year.

Technology:

- Ok if someone is unable to attend (I think this was referring to an Officer or Director)
- Have the technology ready to go.
- It's a great tool if it is used correctly and efficiently.

Hospitality Room:

- Why are we still doing this?
- Announce location and times it will be open.
- Keep it under the jurisdiction of the membership department and ask Granges for funds.
- Do away with it. Food should be provided by the hotel and the State Grange should pay for it.

Now with all these suggestions and ideas from the Granges, I will be working with the State Master, other State Officers, Directors and some fellow members to see how we can offer our members a session that they want to attend with activities focusing on what the members want. Stay tuned for more information!

Again, this year we will not be conducting a session survey. However, if you do have any other ideas or suggestions, please write them down and give them to me or leave them at the credentials table.

Now back to the coordinator part of the report. I'm sure most of you who attended last year can remember that with the cost of the hotel rooms last year, the State Executive Committee voted to pay a portion of each room rental for each night during the session. This was intended to be a one time offering. That being said, I am happy to report that they have again voted to help with the cost of the guest rooms by paying \$25 per night for each room. The staff have deducted this from the balance of each room and will be billing the NH State Grange.

One popular suggestion received from the questionnaire was location of State Session. Several Granges were in favor of having session in the same location for a few years. As a result of that suggestion, I'd like all of you to block your calendar for October 15-18, 2026, for State Session at The Fireside Inn & Suites in West Lebanon, NH.

Thank you, Worthy Master, for allowing me to continue as the Session Coordinator. This is truly a position that I enjoy, and I look forward to planning the 2026 Annual Session.

STATE GRANGE BUILDING MANAGER

Assorted Grange friends,

Last year I began my report by saying it hadn't been a very eventful year at the State Grange building. This one wasn't too exciting either, but that's not a bad thing necessarily. I also said we'd gotten nearly nowhere with the groundskeeping issues. It's been two years on that also. That's a little more of an issue, but we remain hopeful.

Things that have been done include arranging for new insurance, servicing fire extinguishers, getting the building inspected for the yearly assembly permit, putting a coat of paint on the back of the building, and replacing some floor tiles. My sister Mary (who is generally fond of painting) volunteered to remedy the fact that no one had ever painted the boards that were put on when the old chimney was replaced with a new metal one some years back. No one told her that the whole building needed painting and she didn't look before volunteering. Learning from the last time I was doing ladder work without a buddy and knowing that the ladders for this project would be much taller, she and I decided to work on it on Thursdays. In my family we have Donut Tuesday, which means we usually go through the Dunkin Donuts Drive Thru on Tuesdays. That's to keep us from going through every day. If someone asks on a different day then I can say "but it's not Tuesday." We also have Raccoon Thursday which is when Winifred the puppet comes out to help with homework and other such things. Mary and I decided to add State Grange Building Thursdays to the list. We figured she could paint the boards on the back and I could do some stuff inside and then we could sort through and organize the records room and that sort of thing. It's been a lot of Thursdays and the back of the building has now pretty much been scraped and painted. I started out helping with scraping while Mary was mostly painting. Eventually I channeled my inner Don Ross and went way up high to do some painting also. He's the last person I remember seeing on a ladder painting there although it has been painted once since then. We're aware that a few spots where the ladders were leaned against the building still need work... and that the back may mostly have one coat but might need more like five... and that the rest of the building also needs to be scraped and painted... and that the color we painted the cement behind the "new" chimney doesn't match the color of the rest of the cement... and that the records room looks the same as it did... but we're working on it.

Rick Bailey gets the State Grange Building hero of the year award. Being somewhat of a "spring into action" type, he volunteered straight away after his first Executive Committee meeting at the building to do a few repairs to the floor that have been needed for a very long time. He has also

agreed to install a door closer on the back door of the building as requested by the fire inspector and plans to fix a door between the meeting room and the dining room that has been sticking. We intend to keep him around.

Beth Merrill (often with Arthur's help) continues to be the custodian, cleaning the building and checking on paper supplies and such. We still rent to the church on a regular basis, some Nepali groups on an irregular basis, and once in a while someone else. Various State Grange events were held at the building, several Grange committees met there, and the Crafty Ladies continue to craft there occasionally.

TREASURER REPORT

Worthy State Master Tricia Taylor, fellow State Officers, Brothers and Sisters all:

GOOD MORNING! It's nice to see everyone bright-eyed and bushy tailed! I'm sure you all are so eager to hear my wonderful Treasurer's report.

The older I get the faster the years seem to go by, this being my thirteenth year as your Treasurer. It seems every year there are new challenges that pop up, this year being no different. On September 29, I met with Doris Newell, past Treasurer of Sunapee Lake Grange, who still had a CD and checking account that had not been turned over to State Grange. We were able to close both accounts, and I received a check for over \$37,000.00, most of which will be deposited into the defunct Grange account. The State Executive Committee voted to allow Granges with Grange Halls to request funds from the Defunct Account to pay for repairs, interest free. If or when those Grange halls are sold those funds will be paid back to State Grange.

As a friend of mine says, “time to back up the truck”. Kim and I returned to Florida right after state session and enjoyed another wonderful winter. We enjoyed a couple of days visiting with Ed and Denise Luttrell both going and coming. On our return home we stopped in Bascom, Florida (yes, it is a town) population 80. It is a farming community northwest of Tallassee. On arriving in Maine, we barely had time to open the cottage up and get our garden going. On May 27 th we headed across the pond to England and spent 2 days sightseeing. Then boarded the Sky Princess and headed to the Baltics, Denmark, Germany, Finland, Estonia, Sweden and Norway. Arriving back in England, we spent 1 day then boarded the Regal Princess and sailed around the British Isles, 3 stops in Ireland, 4 in Scotland and last Paris, France. These 2 cruises were because of the lost ports on our world cruise. Just before we left on those cruises, I was able to do two deputy visits and one State Officer visit. When I was State Master, 25 years ago, I visited all the Granges in the state except for two. One has since closed and the other, Mt. Pistareen Grange, I visited on May 13, 316 miles round trip. They have a day care using the building which makes things interesting. I haven’t sat in a chair that small since I was about 6. This is a small Grange, but they are very busy in their community, and I would encourage others to visit.

In July I continued my deputy visits and met with Tuftonboro Grange. In September, I was able to set up a meeting with Mt Livermore Grange, my other officer’s visit. State Master Taylor, Arthur Merrill and General Deputy Heath also attended. Master Ed Ford agreed that they should consolidate with Lower Intervale Grange. This was confirmed on October 6.

Concerning State Officer visits, the Executive Committee voted to pay mileage to each State Officer who gives a report of their visits to the State Session starting this next year.

As for my deputy visits, I completed my last one last Friday except for Lake Shore which has not met for two years.

As for our accounts, the year started out with very shaky investments. When it came time to send out escrow checks I delayed them but at the end of April they rebounded, and the checks went out only a couple of weeks late. I am very encouraged by the investments, and we are looking for a bright future financially. As of the September quarter, our financial net worth for all accounts is almost 2 million dollars. The breakdown for our main accounts is as follows.

Operating Account - \$ 300,897.89

Defunct Grange Account - \$ 446,906.30

Educational Loan Fund - \$ 230,562.10

Randel Richardson Youth Fund - \$ 49,051.16

Trust Fund - \$ 107,851.82

For those Granges that I have escrows for, I have printouts of your accounts. Please see me later.

I again have filed all the ePostcards and you will find them in your packets. This is the year all Granges must re-file for NH Corporate Non-Profit status. I have sent out 3 reminders plus info in the GSG and the Grapevine. As of October 15th, 15 Granges have still not filed. This needs to be completed before December 31.

This afternoon you will be voting on the new budget. I have proposed a deficit budget as I am carrying too large a balance in the checking account. Please look over the budget carefully as we will be discussing it after lunch.

The State Grange Trust fund still continues to be underused. We only had one applicant again last year. This fund is to provide financial assistance for any member needing help such as rent, utility bills, auto repair, heating oil, medical bills, etc. The Educational Loan Fund is another underused account. This past year only one member applied for assistance.

Bonding continues to be an issue for many Granges. The rate from National Grange increased again this year. The State Secretary and I cannot provide you with bills as bonding is based on your treasury. If you have questions, please contact me.

I have completed all the paperwork for our accountant and dropped it off in Concord on our way here. As soon as the budget is passed, I will send all the financial info to Mary for printing it in the Journal of Proceedings.

We have closed or consolidated three Granges this year and unfortunately there will be more to come. We also need to be very conscious of our Golden Sheaf members when Granges close. They should all be transferred to new Granges. Our strongest efforts need to be put into recruiting new members.

I want to thank Anne Boisvert for stepping up to the plate. She has made all the deposits for me so that there will be no chance of losing them in the mail. Though she confuses me when she sends me the deposits and says she deposited them on such and such a day, for example 10/2 Yom Kipper deposit and 9/24 Jim Henson's birthday deposit.

Mary, what can I say, your undying effort to get me the bills and vouchers on time are very much appreciated. Kim thanks for always keeping me on the straight and narrow.

Lastly, I want to remember Ida Hutchins and Virginia Clark, they are two members I have always looked up to. They will be greatly missed by us all.

The meeting was called to order at 3:15 pm by Chairman Arthur Merrill.

The following email votes took place prior to this meeting:

- Motion made by Lester Gibbs and seconded by Beth Merrill that NH send two delegates to the 2025 National Convention with the State Grange paying appropriate reservation fees and expenses in advance if requested. Motion was made by Beth Merrill and seconded by Tricia Taylor to amend the above motion to specify that Daniel Bascom be our second delegate to the 2025 National Grange convention with the NH State Grange paying all expenses. The amendment passed on January 19. The amended motion was declared a vote in the affirmative with five votes in favor on January 20.

- Motion was made by Beth Merrill and seconded by Anne Boisvert to approve the request of the State Treasurer and choose the insurance policy offered by Eames Insurance. It was declared a vote in the affirmative with five in favor on February 4.

Secretary's Report: Dorchester, Blow Me Down, Pemi Valley Pomona and Mascoma Valley Pomona did not submit their fourth quarter reports. The Journal of Proceedings is finally in the proofreading stage. After months of failure the webmaster is finally making slow progress. Updating the site has caused discovery of a number of discrepancies that the secretary will strive to rectify. A motion was made by Jerry Leclerc and seconded by Tricia Taylor to approve the Secretary's report. It was a vote in the affirmative.

Master's Report: The NE Leader's Conference was held in Massachusetts. Tricia attended Saturday and Sunday. The workshops were interesting. She found the second workshop to be the best as the presenter made them think about what the Grange offers and how to communicate that to others. She acknowledged the reality that if we don't begin to grow, we will not continue to exist. Although not a Granger, she has been working with the MA State Grange so she does have some experience with what is happening with our organization.

Arthur and Tricia flew to the National Grange's Leaders Conference in California – too far to drive. This year's conference was much better than the others she has attended. There were plenty of worksheets about by-laws. The sessions were well thought out and kept them involved. The best one of all concerned how people judge others, whether it's by race, gender identity or anything different from ourselves. The two presenters were friends but started by sharing what they were thinking when they first came in contact with each other and they eventually worked their way through the first judgements of each other and realized how wrong they were once they got to know each other. It made us all really think about how we treat people. They learned that Granges with halls assessed at \$500,000 or more need to fill out the long form for the I-990N. Next year's conference will be the first weekend in May.

Tricia heard from Ben Anderson's lawyer regarding Bakers River Grange's hall. She was hoping to have the deed drawn up by the end of February and ready for signing but has not been in contact since. Letters were written to Lake Shore and Mt. Livermore to let them know if they don't start meeting the State Grange will stop their escrow payments. If that doesn't convince them to start meeting Tricia will be looking at pulling their charters. Mascoma Valley Pomona was also notified that if they don't start meeting their charter will be pulled.

Tricia spoke with Juno from American Income Life. She would like the chance to change the people calling to professionals who understand the word no. If this happens, would we agree to hold to the agreement? Keep in mind that National Grange has also partnered with them and if we no longer have our own agreement we expect when National Grange figures it out we will be added to their agreement, with no control at all. Motion made by Jerry Leclerc and seconded by Rick Bailey to accept the Master's report. It was a vote in the affirmative.

Treasurer's Report: Submitted via email: 2024 Taxes are done. New State Grange building insurance with Ohio Mutual through Eames Insurance Agency. The incorporation/nonprofit fee

is paid. He sent an article to the GSG concerning the nonprofit report and how to get a paper form. Reminder letters to those Granges who have not paid bonding were sent out on 1/21/2025. - Motion was made by Lester Gibbs and seconded by Tricia Taylor to send NH's membership list to the National Membership Director per National bylaws. The motion passed on July 19, with six in favor and one abstention.

Treasurer's Report: Dan Bascom presented the current income and expense reports. Income is on track for what was proposed, but expense is over. The checking account is still in the black. A motion was made by Tricia Taylor and seconded by Rick Bailey to accept the treasurer's report. It was a vote in the affirmative.

Secretary's Report: Blazing Star, Dorchester, Londonderry, Wingold and Pemi Valley Pomona Granges have yet to submit their second quarter reports. Lake Shore and Mt Livermore are both behind by two quarters. Mascoma Valley Pomona is even further behind. Mary spoke with Londonderry Grange's secretary yesterday to try to straighten out the discrepancies in their membership list. NH's membership list was forwarded to Amanda Brozana on July 23. Tricia is on the Citizenship Committee, which has already received eight resolutions. They are meeting as needed, when resolutions are submitted. She did attend the Zoom meeting to introduce the new website – Grange Growth. Its tentative launch date is September 7. It is a very extensive program with many new opportunities for our members. There will be a discussion site for Grange matters, a site for events around the country, a place to share fundraisers that would allow Grangers from other states to purchase items, etc. Tricia suspects there will be some kind of video roll-out for each of the State Sessions from Sept. 7 on. Wayne Elliot Bequest - 1,000.00

Earlier this year we received correspondence from a Boston lawfirm. Mr. Elliot left \$5,000 to the Hampton Falls Grange, which is not in active status. Under Grange law, the successor organization is the State Grange. The State Grange Exec. Committee reviewed the amount and the intent of the amount to be in a scholarship. The state treasurer was consulted. Leroy received a response back from Arthur saying that the Exec. Committee that they waive any rights to the funds, and thought that the Foundation was the right organization to receive the money. Intended for scholarships. The estate is not settled yet. There are a few issues related to the sale of Mr. Elliot's house, which is the source of the money for the bequests. Leroy asked for any questions. A question came from East Rockingham Pomona, who said that Hampton Falls Grange consolidated with Gilman. He had no objection. There were no objections from either Grange at this point. Leroy moved to accept the bequest of \$1000 from the estate of Wayne Elliot for the purpose of scholarship funds. Andrew Savage seconded the motion. Unanimous in favor by the board, the Grange voted unanimously in favor. The Grange Foundation will be the name on the check.

Request for Money:

Leroy said that under new federal tax changes, every individual will now be eligible to deduct up to \$1,000 per year on their federal taxes for charitable donations. Now, even if you use the standard deduction, you can still deduct up to \$1,000 per person. As a reminder, he suggested that they remember the New Hampshire Grange Foundation as one of your charitable recipients.

President's Report

Good evening, fellow Grange members as well as members of the Grange Foundation Board.

I bring my annual President report to the Board Members as well the Officers, delegates and members of the NH State Grange.

This year we approved five scholarships, in total amount of \$16,500 four scholarships at \$3,750, for \$15,000. One scholarship at \$1,500.

If you are looking for educational opportunities the Grange Foundation's requirements are as follows:

Post-Secondary: student enrolled in an accredited institution of higher education leading to a degree
